 - Hasn't divided out the cost of every league but just doesn't have it yet because of check labeling
 - He will sit with Andy one night and go over the numbers IS THIS AN ACTION ITEM?

- We pay paypal \$600 in registration fees because that's what they take!!
 - This is not okay
 - LAOUT is a business account
 - We are just losing money
 - 2.9%
- O What's the refund policy?
- Categorical costs Andy has these things in the budget Spike will ask to upload so they are all in once place – he said he would ask, but wasn't that asking? ACTION ITEM?
- The running balance number is the issue if it drops we can't pay our bills and Spike is worried about it
 - Andy shouldn't front this money on his credit card
 - If he wants to earn miles, fine, but the organization should be able to front this money
- Spike wants summary and mentions trends again
- City of SM handles beach League
- o 3 big times money goes in and out (parties, fields, uniforms) SPH, SL, WL
- May we gain money June we lose it (SL and bills)
- A couple static costs (charitable trust, website, insurance)
 - Comes from excess
 - Isn't calculatable in league costs

- Cannot grow as we are now

- Spike also types these in "Financial Goals" tab so go look at that

 - Goals meeting though should happen before membership

- Come with an argument about your passionate WHY so we don't just spend time arguing about a financial goal... I think – have something in advance in email form that someone is excited about from this list of \$500 goals so we have time to think and react to this in a meeting in a discussion
- Seth likes the time to process I have garnered from the past couple meetings
- Woz proposes picking out a meeting a couple months down the road then we send out a proposal in advance if we want something
 - We should also revisit where we can save money instead of just how we can raise money – Seth
 - We have no money right now Remy
 - Let's prioritize some of these Alison
 - What kind of money do we need and how? -Alison
 - Participation is dropping off drastically in all leagues -Remy
 - That's the priority discussion -Alison
 - In the model he's seen, normally at a business or another non-profit, each department would yearly submit something to Andy + Treasurer, this is what we are spending this year – they talk about it with the Chair and the VP – core officers – then they say yes or no, or we want more discussion on this, etc etc. (Very future and thoughts on bylaws) -Grant
 - Please take away duplicate and color code and group by money amount
 -Jane
 - She's a stats phD person
 - Common practice is to submit a budget request for what you want for the next year, but we need to identify what our budget is, we don't have one to spend yet, do we focus on the experience for existing players (immilurating it – what does that word mean?) or do we really try to find new people -Woz
 - Seth doesn't think that the culture off of showing up to something off of a facebook ad is supportive of new, non-athletic people – and Woz notes that that is a per captain experience, and postpones that that is a conversation for the future
 - Alison proposes doable goals and start small, and if we go to a membership model, we can have that nominal amount
 - Seth brings up ex. Lined Fields we can buy lined fields, but do we have people to set them up – potential incentive program for volunteers (summer league boys want ittttt)
 - Woz brings us bac 4 minutes on this discussion
 - Action Item for Spike for next meeting or the meeting after everyone prioritize these things, and we will create a mass doc with everyone's preferences and then we can look at it all together
- Last activity spend 3 minutes and write down how to raise money
 - New tab on spreadsheet see the "How?"
- Leiout is prepared to donate 5% of the profits starting retroactively starting this past year
 - Because we aren't a 501C3 we have to pay the taxes ballpark is \$12,000 minus \$3,000 for taxes

- It is in the works but may come in August but can't base LAOUT's future on Leiout's money (can someone change their name)

- Code of Conduct and Disciplinary Action Brainstorming Time
 - o Preliminary discussion and outline won't fully flush it out tonight
 - Per Andy's suggestion we shoul invite Brian in person when we make a final decision and give him the option to defend himself and bring representation in the form of a lawyer
 - o Is that fair when there's 10 of us saying we think this? -Remy
 - We should go to him, given LAOUTs code of conduct, here's how we feel your behavior detracts from that – do you agree or not? Defend yourself, here's our decision. -Woz
 - o Brian or also Hale?
 - At first it's universal as a policy then we talk specifics
 - How should people behave as a part of our league? What is our consequences and punishments for said people?
 - Is this LAOUT League events? Only what people are paying for and LAOUT sponsored events – we don't take ownership of Club or Pickup. We can't use examples from those events then – that's the line. You can't use someone's misbehavior at pickup. General behavior towards Frisbee people though can be cited as to why they can't play a league.
 - o Is this complaint oriented? Does the board then investigate?
 - We talk about crying experiences because #bonding and people are dicks. Humanity is sometimes disappointing.
 - Through our registration process we must have a code of conduct or a waiver paragraph or initial here.
 - o Are there anonymous complaints or do people have to own up to it.
 - A committee should handle this type of thing Advisory Board? Jane and Grant speak
 - Where is the line if you're punishing your friend? The idea of a group decision, but them not knowing what 4 people are on the panel, so Brian Kuhn doesn't roll up at 2AM and yell at you Romeo and Juliet style outside your window.
 - The committee should write up a report and advise the entire board, and the entire board votes.
 - o This won't be super frequent hopefully?
 - We talk about Cory and Nicole throwing Frisbees over the fence and Frankie 00001
 - Opportunities to intervene before it gets bad as a SL captain or a WL captain to prevent escalation -Seth
 - Tools for captains to use? -Alison
 - Do people get a warning first? First time offenders? Depending on the severity of the thing... That's the job of the committee case by case, but if we have a set in stone rule, "commit violence, you're out for a year" or whatever – that's the rule sorry
 - Seth has questions
 - Is this interaction with other people or is it egregious behavior on the field like reckless play or terrible calls.
 - Separate poor spirit from abusive, violent behavior Allison

- Allison will draft a code of conduct and mention good spirit as well and also potential discipline procedures – ACTION ITEM
 - Revisiting this during the June Meeting June 21
- Yo Brian, we are starting a code of conduct if you do anything similar to what happened last time – you're done. Remy gives a summary of St. Pats Hat incident with Brian.
 - Stephanie Hicks (Remy's matchup) recognizes she's not in the endzone. Brian starts screaming. Remy is stalling. Stephanie told Brian to shuttup she wasn't in. Brian starts to yell that Remy always cheats. Andy reacts. Brian says, I won't take it back, I'll have a conversation about it, but I won't take it back. Then Stephanie scores. Randy starts a fight with Brian because no one likes Brian – then yells at Remy, then apologizes.
 - If you don't conform, you have to, sorry -SOTG. If you're a new player whose an athlete, fine you get a 2nd chance.
- ACTION ITEM Seth will talk to Brian and potentially Hale if he signs up regarding summer league – it will be chill and light, but no bullshit.
 - Allison tells OLOB story about Hale.
 - She waves him off after a turn when he wanted to pickup he was getting very excited, so she walked slowly over to the disc.
 Hale unleashes a torrent of obscenities and it goes on and on, many F words. Allison stops walking. Jane calls a TO (on the opposing team), then her team came back from like being down 1-6 to win the game.
 - Hale doubled down I have every right to yell at you, I did nothing wrong.
 - Seth tells back in the day stories about Jeff Landesman but he has changed.
 - Hale and Brian lack self-awareness and the misperception of a shared reality is disconcerting.
 - Seth will not leave a window for pushback if they feel anything then they shouldn't play the league.
 - Warning- kicked out of League kicked out of LAOUT
 - o 3 stages
- Seth wants to ask things of Summer League captains
 - He will send out an email to the Board with some suggestions
 - Welcome to the SL captains dinner buy Pizza and Beer
 - Some kind of captains gift you could do it at the draft feed the captains at the draft but it slows the draft down
 - Egregious sandbagging people feel it's a huge issue
 - As long as 2 people know someone it's not that bad but the perception is bad
- ACTION ITEM:
 - Chuck, Jane, and Woz owe ultimate bios
 - Woz owes language for age restriction
- Seth wants another meeting about Leagues
 - He doesn't forsee any attendance on the next meeting West Side
 - An overall meeting is suggested by Spike
- We talk about beginner's league v. a coached league v. what IS summer league?
