#### **Continuing Action Items**

- LAOUT's Field Manager is meeting with Rancho Cienega Recreation Center to discuss future permits on 11/19/2019
- We are still working through paperwork with LAOUT's current insurance broker who has been less than timely in responses
- A formal, written sub policy has been shared with the Board but needs a few changes, given recent discussions, before consideration to vote into place; changes will be shared with the Board by Friday
- Budget numbers for 2019 membership were prepared and shared
- Two similar but differently formatted player ranking systems were shared with the Board; the UltimateCentral system appears to be ready for more broad testing
- A survey about LAOUT membership was distributed on November 7, 2019
- We have officially signed and entered into a two year contract with Spin that runs through December 31, 2021

Update on Fields

- There is also a permit application submitted to Santa Clarita for the Winter BYOT League tournament on March 7, 2020

Update on SCYU

- USA Ultimate memberships for under-resourced students from Montclair HS should come through on December 1, 2019
- There will indeed be a 24 player showcase series on January 4th that USAU and California Ultimate will produce during the concurrent youth and adult hat tournaments

- There is a new team from Torrance competing at Beach of Dreams as well
- SCYU is looking for volunteers in the LAOUT community to host youth teams from outside the greater LA area to help allow more teams to attend; maybe this can go in the newsletter?

## Update on Leagues

• League Committee drafted a sub policy for review, gave recommendations for changes to the Air Quality Policy, and also created a rough draft 2020 schedule of definite and probable LAOUT events

## Update on Equity

- Equity Committee proposed the Board start collecting demographic information (based on USAU's collection) about gender identity, gender matching\* (this one is additional), annual income, education level, employment status, marital status, & race
  - There will be additional research (internally and concerning UltimateCentral/TopScore) and data restrictions applied, and subsequently informative language will be written to inform the community of our purposes for collecting data which is to better identify which demographics we are currently serving and which we need to create more programming to get involved in our community
- Equity Committee proposed the Board adopt a sliding-scale fee structure for Spring and Fall Beach Leagues; more discussion, modeling, and practical implementation steps will be explored before introducing to the community
- Equity Committee proposed all future registration pages make our scholarship opportunities and process more visible

## Additional Business

## 1. AQI Policy Changes

- a. Unanimous vote to change policy as per League Com's suggestion
  - i. Between 101-150 AQI team captains will have the choice to either request a reschedule without forfeiting, both accept a cancellation, or play a game to 9 with both teams being given 2 options timeouts per half
  - ii.

# 2. Event demographics and retention model

a. This model uses a single export from UltimateCentral and tracks how many participants have played in each event for the year; working to include a multi-year retention metric
